AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF CRIVITZ,
MARINETTE COUNTY, WISCONSIN

THE PRESIDENT AND VILLAGE BOARD OF THE VILLAGE OF CRIVITZ, MARINETTE
COUNTY, WISCONSIN, DOES HEREBY ORDAIN AS FOLLOWS:

I. TERRITORY ANNEXED.

In accordance with Section 66.0217 of the Wisconsin Statutes and the Petition for direct annexation, by unanimous approval, filed with the Village Clerk on the 27th day of July, 2022, signed by all of the owners of land in the territory, in which no electors reside, of the following described territory, as depicted in the attached Exhibit, located in the Town of Stephenson, Marinette County, Wisconsin, is annexed to the Village of Crivitz, Marinette County, Wisconsin:

Parcel 1: Lot 1, Certified Survey Map No. 1120, recorded in volume 7 Certified Survey Maps page 244, as Document No. 551489, located on part of the Southwest Quarter of the Southwest Quarter (SW1/4 of the SW 1/4) of Section 22, Township 32 North, Range 20 East, EXCEPT South Street, in the Town of Stephenson, Marinette County, Wisconsin.

Tax Parcel No. 032-02636.002

Parcel 2: Part of the Southwest Quarter of the Southwest Quarter (SW 1/4 of the SW 1/4) of Section 22, Township 32 North, Range 20 East, in the Town of Stephenson, Marinette county, Wisconsin, described as:

Beginning on the North line of said forty, at a point 594.1 feet West of the Northeast corner of said Southwest Quarter of the Southwest Quarter; thence North 88 deg 18 min West, on the North line of said forty, 540.5 feet; thence South 24 deg 22 min West, 300 feet, along the East line of the Chicago, Milwaukee, St. Paul & Pacific Railway right-of-way; thence South 65 deg 33 min East, 100 feet; thence North 24 deg 27 min east, 309.4 feet; thence South 88 deg 18 min East, 414.8 feet; thence North 46 deg 42 min East, 42.4 feet, to the Point of Beginning.

II. EFFECT OF ANNEXATION.

From and after the date of this Ordinance, the territory described in Section 1 shall be a part of the Village of Crivitz, Marinette County, Wisconsin, for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the village of Crivitz.

III. TEMPORARY ZONING CLASSIFICATION.

The territory annexed to the village of Crivitz by this Ordinance is temporarily zoned Industrial District, pursuant to Section 66.0219(6), Wis. Stat. The Development Committee is directed to prepare an amendment to the zoning ordinance setting forth the permanent classifications and regulations for the zoning of the annexed area.

IV. SEVERABILITY.

If any provision of the Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not effect the other provisions or applications of the Ordinance, which can be given effect without the invalid or unconstitutional provision or application.

II. EFFECTIVE DATE.

This Ordinance shall be adopted under suspension of local rules, and shall take effect upon passage and publication as provided by law.
