

ORDINANCE NO. 2026-005

VILLAGE OF CRIVITZ

AN ORDINANCE AMENDING CHAPTER 36, ARTICLE II, DIVISION 1, SECTION 36-37 RELATING TO RESTRICTING THROUGH HEAVY VEHICLE TRAFFIC ON ROSA AVENUE.

THE VILLAGE BOARD OF THE VILLAGE OF CRIVITZ, MARINETTE COUNTY, WISCONSIN, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. PURPOSE

The purpose of this ordinance is to protect Rosa Avenue from damage caused by heavy vehicles using the roadway as a shortcut or through route, while still allowing local access, deliveries, emergency response, municipal operations, utility work, and legitimate access to properties located on Rosa Avenue.

SECTION 2. THROUGH HEAVY VEHICLE TRAFFIC PROHIBITED

No truck, commercial motor vehicle, farm truck, farm equipment, tractor-trailer, or similar heavy vehicle shall use Rosa Avenue for through traffic or shortcut travel.

SECTION 3. EXCEPTIONS

This restriction shall not apply to:

1. Emergency vehicles;
2. Village, county, state, or other municipal vehicles performing official duties;
3. Utility vehicles performing service, repair, construction, or maintenance work;
4. Vehicles making local pickup, delivery, or service calls on Rosa Avenue;
5. Vehicles accessing property located on Rosa Avenue; or
6. Vehicles accessing property that has no reasonable alternate access except by using Rosa Avenue.

SECTION 4. SIGNAGE

The Village Public Works Department is authorized and directed to install appropriate regulatory signage on Rosa Avenue, including **NO THRU TRUCKS** signs, and any additional signage deemed necessary to provide notice of this restriction.

Regulatory signs shall be installed in accordance with applicable traffic-control signing requirements.

SECTION 5. ENFORCEMENT AND PENALTY

Any person violating this ordinance may be subject to citation and penalty as provided under the Village of Crivitz Municipal Code, including any applicable forfeiture, court costs, and assessments.

SECTION 6. EFFECTIVE DATE

This ordinance shall take effect upon passage and publication as required by law.
